UPON hearing the counsel the Court made the following
O R D E R

1. Heard Mr. Sukesh Ghosh, learned counsel for the petitioner and Mr. Parag Chaturvedi, learned counsel for the State.
2. When the matter came up on 23.03.2026 before this Court, learned counsel for the petitioner prayed for bail citing parity with accused-Babu Chatterjee @ Dipendra Narayan Chatterjee who had been enlarged on bail by the High Court vide order dated 14.10.2025. On this basis, notice was issued to the respondent-State.
3. Today, Mr. Parag Chaturvedi, learned counsel for the State

points out that an application for cancellation of the bail of accused-Babu Chatterjee @ Dipendra Narayan Chatterjee in C.R.M.(M)2434/2025 has been moved before the High Court of Judicature at Kolkata and the same is likely to be listed in the near future.

4. In view of the same, we are of the opinion that the present matter also should be taken up along with the case of the accused-Babu Chatterjee @ Dipendra Narayan Chatterjee.

5. Accordingly, we set aside the impugned order and remit C.R.M.(NDPS) No. 1384/2025 for fresh consideration before the High Court to be heard along with C.R.M.(M)2434/2025. The prayer of the petitioner is allowed.

6. The Special Leave Petition is disposed of in the above terms.

7. Pending application(s), if any, shall also stand disposed of.
