UPON hearing the counsel the Court made the following
O R D E R

Heard learned counsel
for the parties and perused the
material placed on record.

Considering the facts
and circumstances of the case,
the period of incarceration
already undergone by the
petitioner which is more than
four years and the fact that
the trial has not yet
concluded with only 6 out of 13
witnesses having been examined
despite the lapse of nearly
four and a half years since
submission of the charge-sheet,
we are inclined to grant bail

to the petitioner.

Accordingly, we direct that the petitioner be released on bail, on such terms and conditions as may be imposed by the Trial Court, in connection with Case Crime No.325 of 2021, dated 06.10.2021, Police Station Bidhnu, District Kanpur Nagar, Uttar Pradesh.

The Trial Court is directed to expedite the trial.

It goes without saying that both the prosecution and the defence shall extend all cooperation in the conclusion of the trial.

In the event, the Trial Court or the State finds that the petitioner is delaying the conclusion of trial, it will be open for them to apprise this Court of the same for appropriate orders.

The Special Leave Petition and pending applications are disposed of accordingly.
