O R D E R

1. Delay condoned.
2. By our Order dated 23-1-2026, we had directed that the National Company Law Tribunal shall at the earliest consider the objections and pass a fresh order on Section 95 application preferred by the appellant.
3. We also directed that the entire exercise shall be undertaken and completed within a period of two weeks from the date of the order.

4. Today, we have one application preferred by the applicant - original Respondent pointing out that there was some delay in preferring the application before the NCLT. The NCLT has now declined to look into the matter as the mandate of two weeks has expired.

5. Having heard the learned Senior counsel appearing for the patties and in the facts of this case, we give one last opportunity to the applicant to proceed with the Section 95 application before the NCLT.

6. Let this application be now heard and decided within one week from today without fail.

7. Dasti permitted.

8. Registry is directed to forward one copy of the order to NCLT, Bangalore at the earliest.

9. With the aforesaid, the applications stand disposed of.
