PETITION FOR SPECIAL LEAVE TO APPEAL (CIVIL) NO. 34962 of 2013

Fresh show cause notice was issued to unserved respondent Nos. 2, 3, 5 to 7. Unserved cover containing the said notice has been received back from respondent Nos. 2, 6 & 7 stating that 'No such construction for this Door No.' 'left', respectively. Neither A.D. card nor unserved cover containing notice has been received in respect of respondent No. 3 and 5.

Service of notice is incomplete in respect of respondent Nos. 2, 3, 5 to 7.

PETITION FOR SPECIAL LEAVE TO APPEAL (CIVIL) NO. 34963 OF 2013
