the petitioner deposits an amount of Rs. 3,00,000/- (Rupees Three Lakhs Only) with the Registry of this Court, within four weeks from today.

Upon such deposit, the Registry shall invest the said amount in an interest bearing Fixed Deposit Receipt (FDR) initially for a period of three months in a Nationalised Bank which fetches maximum rate of interest with an auto-renewal mandate.
