O R D E R

1. The petitioners challenge the judgment and order dated 05.02.2026 in CRM-M No.2592 of 2025, titled "*Rohit Kumar Jaiswal Vs. The State of West Bengal & Ors.*", passed by the

High Court at Calcutta.

2. We have heard learned counsel for the parties and perused the material available on record.

3. It is brought to our notice that post-filing of the present petition and passing of our order dated 13.03.2026, the petitioners had surrendered before the Trial Court and obtained regular bail.

5. As and when any such proceedings are initiated, the Court shall decide the same on its own merit, uninfluenced by any orders passed by this Court.

6. Accordingly, the present Special Leave Petition is disposed of.
