O R D E R

1. Learned counsel for the petitioner invites our attention to the document- Annexure P-1 i.e.the registered Sale Deed (page 17) dated 21.06.2018 which the petitioner had executed with the complainant. It is submitted that the findings of fact recorded by the High Court in paragraph 6 of the impugned order, are factually incorrect.
