**O R D E R**

1) Leave granted.

2) In the instant appeal, the High Court *vide* impugned order dated 22.01.2026 dismissed the CM APPL. No. 4325/2026 in RFA No. 428 of 2025 preferred by the appellant herein, referring that the other pending applications (CM APPL. Nos. 29269/2025 and 29275/2025) would be heard by the Roster Judge hearing the RFA.

3) After hearing learned counsel, we find that the application, i.e., CM APPL. No. 4325/2026 filed by the appellant was also required to be referred by

the High Court to the Roster Judge for hearing along with CM APPL. Nos. 29269/2025 and 29275/2025. In this view of the matter, the dismissal of CM APPL. No. 4325/2026 directed *vide* impugned order shall stand set aside.

4) However, the High Court is requested to hear all these applications, namely, CM. APPL. Nos. 4325/2026, 29269/2025 and 29275/2025 simultaneously and decide as expeditiously as possible without being influenced by this order. The High Court may take up this matter as far as possible at the earliest, on the next date of hearing or within month, if hearing is not possible on the date so fixed.

5) Accordingly, the civil appeal stands disposed of. Pending application(s), if any, shall stand disposed of.
