We find that many of the States/Union Territories have not responded to the directions issued by this Court.

We are informed by Mr. K.K. Venugopal, learned senior counsel, that notice has already been served on the Standing Counsel for all the States/Union Territories. In such circumstances, those States/Union Territories which have not filed their response, are directed to file their response within a period of one month.

Union of India is also given liberty to file additional counter affidavit or a status report after studying the response filed by all the States/Union Territories within one month thereafter.

Learned counsel appearing for the States/Union Territories will also make available a copy of their response to Ms. Indira Jaising, learned Addl. Solicitor General of India.
