O R D E R

Learned counsel appearing for the appellant states that he is carrying a demand draft of Rs.9,00,000/- (Rupees Nine Lakhs only), which he shall deposit with the Registry of this Court today itself. Let the said amount be deposited and be placed in an interest bearing account with a Nationalized Bank, initially for a period of three months, to be renewed

periodically.

The amount aforementioned, which is to be deposited, and the amount deposited pursuant to order dated 17.03.2026, shall be paid to respondent no.1 either by way of account payee cheque or in case bank details are provided within a week from today, the Registry shall transfer the same electronically in the said account.

Learned counsel for the appellant informs that the balance amount would be paid within a period of two months.

Let these appeals be listed again on 13.07.2026.

In the meantime, the balance amount shall be paid directly by the appellant to respondent no.1. The bank details may be provided by the learned counsel for respondent no.1 to the learned counsel for the appellant.

In view of the aforesaid deposits being made and the statement given that the balance amount will also be paid, further proceedings in case No.EP/0001781/2022 titled *Chandrasekaran vs. Flora*, pending before the Court of IX Assistant City Civil Court, Chennai, shall remain stayed.
