O R D E R**

- 1) Application for exemption from filing certified copy of the impugned judgment is allowed.
- 2) Complainant be joined as a party.
- 3) Issue notice.
- 4) Mr. M. K. Maroria, Advocate on Record, accepts notice for respondent-State
- 5) Mr. Siddharth Jain, Advocate on Record, appears and accepts notice for complainant.

6) Counter affidavit may be filed within four weeks.

7) With the consent of both the parties, the matter is referred to the Supreme Court Mediation Centre for mediation.

8) We request the co-ordinator of the Mediation Centre to appoint a senior Mediator to mediate the issues between the parties.

9) Parties to remain present before the Mediator on 20.03.2026, at 11 a.m.

10) On the first date, i.e., 20.03.2026, mediation may take place by virtual mode. Thereafter, the parties have agreed to appear personally as per the instruction by the Mediator.

11) After consultation, the report of mediation be made available as

expeditiously as possible and preferably before the next date of listing.

12) In the meantime, by way of interim relief, it is directed that subject to cooperation of the petitioner in the investigation, no coercive steps shall be taken against him in connection with FIR No.90 of 2025 dated 28.08.2025 registered at Police Station Tughlak Road, New Delhi.
