Leave granted.

2. We have heard learned senior counsel for the appellants and learned senior counsel for the respondents extensively.

3. The controversy in these appeals is with regard to the interim direction issued by the Division Bench of the High Court directing the appellants herein to furnish an unconditional and irrevocable bank guarantee covering the entire principal amount of damages awarded by the Single Judge being Rs.6,22,50,000/-. The Review Petition filed against the said order was also dismissed. Hence, these appeals.

4. Having regard to the fact that the appeal(s) is still at large and has to be heard on merits, we find that in the interest of justice and in order to balance the interest of both parties, we modify the amount ordered by the High Court by stating that a sum of Rs.3 crores shall be furnished towards an unconditional and irrevocable bank guarantee which would be subject of result of the appeals pending on the file of the High Court.

5. This order shall be complied with within a period of three weeks from today.

6. In the event there is non-compliance of this order, the direction issued by the Division Bench of the High Court shall revive automatically.

The appeals are disposed of in the aforesaid terms.
