O R D E R

Issue notice, returnable on 13.05.2026.

Mr. Samar Vijay Singh, learned counsel, who is present in

Court on advance notice, waives service and accepts notice for the State of Haryana. He seeks time to enter appearance and file a counter affidavit/reply.

Needful shall be done within four weeks from today.

Rejoinder thereto, if any, may be filed within two weeks thereafter.

We find from the impugned order that the complainant was heard by the High Court, but he was not made a party to the proceedings. We deem it appropriate to implead the complainant *suo motu* as respondent No. 2 in this special leave petition. The details of the complainant are as under:

Sheikhpura Mohalla, Palwal, Haryana.

Service on the newly impleaded respondent No.2 shall be effected by all modes, including *dasti*.

Liberty is granted to the said respondent to file a counter affidavit within three weeks from the date of service of notice.

Rejoinder thereto, if any, may also be filed by the next date of hearing.

In the meanwhile, subject to the petitioner, Jatinder Kumar @ Jatin, joining and cooperating with the investigation in connection with First Information Report No. 65/2024 dated 02.02.2024 registered with Police Station - City Palwal, District - Palwal, Haryana, for offences punishable under Sections 420, 406, and 120-B of Indian Penal Code, 1860, he shall not be arrested till the next hearing. In addition, the petitioner shall scrupulously abide by the conditions stipulated in Section 482(2) of the Bharatiya
