**UPON hearing the counsel the Court made the following  
O R D E R**

1. An application seeking modification of the Order

dated 29.01.2026 has been filed, *inter alia*, stating that preparation of the list was confined towards Appellants and Intervenors who approached to this Court on or before 29.01.2026. It has been submitted that certain aggrieved persons have availed the remedy before High Court and their matters are pending for adjudication. It has further been brought to the notice that some of the Writ Petitions were already disposed of in the light of the impugned Order, however, the order may be modified to such extent.

2. Having regard to the submissions, it would be suffice to direct that *apropos* the previous order the list be prepared commensurate with the available vacancies, strictly on merit, in accordance with the directions including Appellants, Intervenors, the Petitioners whose matters are pending before the High Court as well as the Petitioners whose Writ Petitions have been disposed of pursuant to the impugned Order.

3. With this view and to carry out such directions, the matters stand adjourned to the

month of August 2026.
