O R D E R

Heard the learned counsel appearing on behalf of both the sides.

On the bail application filed by the co-accused Vishal Yadav,
the High Court

enlarged him on bail subject to his furnishing a personal bond in the sum of Rs.5,00,000/- with

two sureties of the like amount. The High Court also imposed certain other conditions. The

mother of the deceased filed a Special Leave Petition No.1227 of 2005 in this Court challenging

the order dt.06.10.2005 whereby the High Court had granted bail to the
co-accused Vishal

Yadav. The petitioner before us has also filed an application for bail before the High Court.

The High Court adjourned the matter awaiting decision of this Court in the
SLP filed by

mother of the deceased. It is stated that the State Government of NCT of Delhi has also filed

an SLP against the order granting bail which is numbered as SLP (Crl.) No.697/2006. In the

said case, this Court has ordered notice to the respondent and granted three weeks' time to the

respondent to file the counter affidavit. It is now stated by the learned
counsel for the

respondent that the said SLP (Crl.) No.697/2006 is listed for hearing on
03.07.2006. Since

some urgency is expressed by the learned counsel for the petitioner, we direct the Registry to

list this SLP along with SLP No.1227 of 2005 (filed by the mother of the deceased) and SLP

(Crl.) No.697/2006 (filed by the State Government of NCT of Delhi) for hearing on 04.07.2006.
