UPON hearing the counsel the Court made the following
O R D E R

1. Heard Mr. Vivek Tankha, the learned senior counsel appearing for the appellant and on the other side Mr. Neeraj Kishan Kaul and Ms. Meenakshi Arora, the learned senior counsel appearing for the respondent nos.1 and 8 respectively.

2. The appeal is admitted.

3. Till the next date of hearing, there shall be a conditional stay of the impugned judgment and order to the following extent:-

(i) The appellant shall be entitled to participate in the proceedings of the Legislative Assembly;

(ii) The appellant shall, however, not be entitled to vote on any motion in the Legislative Assembly. He shall also not be entitled to vote in his capacity as a Member of the Legislative Assembly on any other matter;

(iii) The appellant shall not be entitled to receive any allowance or monetary benefits in any other form which is admissible to a Member of the Legislative Assembly.

4. Insofar as what has been held by the High Court as observed in Paragraph 59 of the impugned judgment is concerned, the same shall remain stayed from its operation.
5. Dasti permitted.
6. Other respondents be served directly.
7. Let the record be requisitioned from the Court below.
