O R D E R

1. We heard learned counsel for the parties.
2. This Miscellaneous Application has been filed by the respondent-husband in a disposed of matter i.e. Transfer Petition (Civil) No.58 of 2022.
3. The prayer made in the Miscellaneous Application is as under:

"a) Issue appropriate directions/orders modifying the terms of the Settlement Agreement dated 09.01.2023 in terms of paragraph 16 (proposed changes/Modification by the Applicant in Clauses of the Settlement Agreement dated 09.01.2023) of the present application and the rest of the terms of the Settlement Agreement dated 09.01.2023 be complied by the Petition in absolute letter and spirit;"

4. There is a huge delay of 1121 days in filing the application. That apart, the Settlement Agreement dated 9th January, 2023 was arrived at between the parties (husband and wife) voluntarily on the basis of which the Transfer Petition was disposed of by this Court on 16th January, 2023 by invoking its jurisdiction under Article 142 of the Constitution of India. In is now not open to a party to the settlement to resile from the terms and conditions of the settlement or seek a direction from the Court to modify the terms of the settlement. We cannot entertain such a prayer. Consequently the Miscellaneous Application is dismissed on merits as well as on delay.
