UPON hearing counsel the Court made the following
O R D E R

On 11.01.2011 this Court had passed the following order:

"Having heard learned counsel for the parties for some time, we feel that in order to narrow down the controversy at hand, it would be desirable and expedient to request the Secretary (Defence Production), Union of India and the Chief Secretary, State of Karnataka, to have a meeting and try to resolve the issues arising for our consideration in these matters. It will be open to the said officers to seek assistance of any other senior officer, who may be conversant with the issues involved in these cases. Let the meeting be convened by the Secretary (Defence Production) within two weeks from today."

Thereafter, the matters were taken up on a large number of dates earlier and on the ground that the Chief Secretary of the State of Karnataka and the Secretary (Defence Production), Union of India are attempting to resolve the issues, the matters were adjourned from time to time. Even after lapse of two and a half year no decision has been communicated to us. In fact, a request has been made to grant three months' time to conclude the ongoing discussion at the government level.

We are not inclined to grant three months' time as we are of the opinion that sufficient time has already been granted. However, by way of last indulgence, we give six weeks' time to take the decision in the light of the order referred to above.

If no decision is taken within the time stipulated, the Secretary (Defence Production) and the Chief Secretary of the State of Karnataka shall be personally present on the next date of hearing, i.e., 12.11.2013 along with the record of the case.

A copy of this Order be forwarded to the concerned officers forthwith.
