UPON hearing counsel the Court made the following
O R D E R

When notice was issued in this special leave petition on 12th May, 2010, we had indicated that the same would be confined to the limited question as to why having regard to the observations made in paragraph 9 of the impugned judgment, the respondent No.8, while making further development and in entering into further transactions, should not inform the prospective purchasers of the pendency of the suit. Pursuant to service of notice, the respondents have entered appearance and Shri Shekhar Naphade, learned senior counsel, is appearing for the petitioner in the special leave petition.

Today, when the matter is taken up, it is submitted that the parties have no objection to such a direction being given. Accordingly, we dispose of the special leave petition by directing that the respondent No.8, while making

further development and while entering into further transactions, must inform the prospective purchasers of the pendency of Suit No.111 of 2008, pending before Civil Judge, Senior Division, Panvel, Maharashtra. It is also made clear that the order of status quo, which had been passed earlier, has since elapsed.
