Pursuant to the order passed by this court on 27th September, 2000, Mr. Harish N. Salve, learned Solicitor General of India today submitted that 25% of the Award amount has been deposited with the Reference Court. In view of the deposit having been made, we permit claimants to withdraw the entire deposited amount provided they furnish security for half of the deposited amount. In other words, claimants can withdraw half of the amount deposited upon furnishing security and the remaining half amount they can withdraw without security if they propose to withdraw it. Execution of the decree would stand stayed till the disposal of the appeals pending before the High Court.
