We have heard Mr. Shree Prakash Sinha, learned counsel for the petitioner and Mr. Amitesh Kumar, learned counsel for the respondent No.1.

2. The petitioner applied for recognition to the respondent No. 1 - National Council for Teacher Education (NCTE) for B.Ed. course on 30.9.2011 for the academic year 2012-2013.

3. By order dated 3.5.2013, the NCTE has granted its approval for B.Ed. Course of the petitioner, but, in the formal order of recognition it is mentioned that recognition will take effect from the academic session 2014-2015 presumably because the cut-off date for grant of recognition for the academic year 2012-13, as fixed by this Court in Maa Vaishno Devi Mahila Mahavidyalaya vs. State of U.P. and others (2013)2 SCC 617 was over by 3.3.2013.

4. In terms of our order dated 10.5.2013 passed in Writ Petition (C) No. 221 of 2013 - M.R. Bharti College of Education vs. National Council for Teacher Education and another, we allow this Writ Petition by directing that the recognition granted by the NCTE by formal order dated 3.5.2013 will apply for the academic sessions 2013-2014 and 2014-2015. We make it clear that this order has been passed in the peculiar facts and circumstances of the case and will not be treated as a precedent by the High Court to deviate from the time schedule fixed in the aforesaid judgment in Maa Vaishno Devi Mahila Mahavidyalaya (supra).
