We are afraid, we can allow such a contention to be raised at this stage according a premium on the lapse of all those concerned at the relevant point of time. Except observing that we do not express any opinion on the effect of the same, we are not prepared to take any different opinion than the one already taken by this Court in the other cases noticed above.
