Learned counsel for the
petitioner submits, upon
instructions, that the
petitioner is ready and willing
to pay an amount of Rs. 8.89
lakhs which had been
admittedly received in the
account of the petitioner.

Issue notice, returnable
on 13th April, 2026

Petitioner is permitted
to implead the complainant as
party respondent no. 2.

Issue notice only to the newly added respondent.

On 13th April, 2026, the petitioner will come ready with the demand draft of Rs. 8.89 lakhs drawn in favour of the respondent no. 2-complainant.

By way of ad interim order, in the event of arrest, the petitioner be released on bail in connection with FIR No. 605 dated 22.10.2025 registered at Police Station Industrial Sector-29, Panipat, Haryana, subject to him

executing personal bonds for a sum of Rs.25,000/- (Rupees Twenty Five Thousand Only), with one or more sureties in the like amount.

However, the Petitioner is directed to cooperate with the investigation and report to the Investigating Officer as and when directed to do so.
