O R D E R

The petitioner seeks transfer of HMA M.P. No. 325/10 pending before the Civil Judge Senior Division II, Mathura (Uttar Pradesh) to the Court of Additional District Judge, Karkardooma

(Delhi). Learned counsel for the respondent submits that although the petitioner-wife has been appearing before the Court at Mathura for the past two years, he will have no serious objection if the petition is transferred to the Court at Tis Hazari instead of Karkardooma, as prayed for, having regard to the fact that the petitioner is a practising advocate at Karkardooma.

In the circumstances, therefore, we allow this transfer petition and direct transfer of HMA M.P.No. 325/2010 titled Gaurav Thakur vs. Smt. Asha Singh from the Court of Civil Judge Senior Division II, Mathura (Uttar Pradesh) to the Court of Principal District Judge, Tis Hazari (Delhi), who may try the case himself or
