It is also submitted for information of the Hon'ble Court that the SLP (C) No. 13705 of 2016 @ SLP (C) No..CC 9794 of 2014 entitled "UNION OF INDIA & ORS. vs M/S.PRAGATI STEEL" arising from similar issue which was listed before the Hon'ble Court on 4th March, 2016, when the Hon'ble Court has dismissed the same. (Copy of order dated 4th March, 2016 is enclosed herewith for reference).
