OFFICE REPORT

The matters above mentioned were listed before the Hon'ble Court on 15.07.2011, when the Court was pleased to pass the following Order:

***“Delay condoned.
Issue notice.”***

Accordingly, show cause notice was issued to the all the 15 respondents through Regd. AD Post. Mr. S.N. Bhat, Advocate has filed vakalatnama/appearance in respect of Respondent Nos. 1, 11 & 12 and also filed counter affidavit and the same has already been included in the paper books. AD Cards, duly signed, have been received back in respect of Respondent Nos. 2, 3, 5-10 and 13-15 but no one has put appearance on their behalf. Counsel of the petitioner has filed application for bringing on record the Lrs. of deceased Respondent No. 4 but the said application was defective. Therefore, an Office Report for Direction dated 14.02.2014 was listed before the Hon'ble Judge in Chambers on 07.04.2014, when His Lordship was pleased pass the following orders:

“Learned counsel for the petitioner submitted that the legal representatives of deceased respondent No.4 are already on record. Therefore he does not press the application.

Hence,application for substitution is rejected as not pressed.”

It may be mentioned here that Lrs. of deceased Respondent No. 4 are already on record as Respondent Nos. 5 to 10 as per the rejected application for bringing on record the Lrs. of deceased Respondent No. 4.

Service of show cause notice is complete.

Thereafter, the matters above mentioned were lastly listed before the Hon'ble Court on 08.07.2015 with an office report dated 07.07.2015, when the Court was pleased to pass the following Order:

***“Counter affidavit by the respondents has already been filed. Learned counsel for the petitioner does not proposes to file any rejoinder affidavit.
Post for final hearing on a non-miscellaneous day.”***

It is submitted that no further documents have been filed by any of the counsel after the above order of the Hon'ble Court.
