UPON hearing the counsel the Court made the following
O R D E R

1. Permission to file the petitions is granted.
2. This batch of transfer petitions have been filed by Tulsi Ram Agarwal, who claims to have been re-elected as President of the Roller Skating Federation of India on 24.05.2025. There are multiple writ petitions pending before different High Courts, the transfer whereof to one High Court has been sought through these transfer petitions.
3. *Prima facie*, it appears that the issues raised before different High Courts are not identical and do not overlap. It may, therefore, not be prudent for this Court to consolidate the proceedings before one High Court. However, owing to the urgency expressed before us, the petitioner may approach the respective High Courts with a request for early/out-of-turn adjudication of the pending petitions. We have no reason to doubt that the High Courts will sympathetically consider the petitioner's request and make an endeavour to decide the pending petitions as early as possible.
4. The Transfer Petitions are, accordingly, disposed of.
5. All pending applications, if any, also stand disposed of.
