4. We have considered the facts of the case and grounds on which transfer has been sought. On such consideration, we are satisfied with the grounds urged by the petitioner and accept the same. Therefore, Marriage Petition No. 1296 of 2025 titled "*Mr. Bhim Ganeshprasad Soni Versus Mrs. Payal Bhim Soni*" pending before the Court of Civil Judge (Senior Division) at Kalyan, Thane, Maharashtra is ordered to be transferred to the appropriate Bench of District Court, Surajpur, Chhattisgarh.

5. Records of the case should immediately be transferred to the transferee court.

6. The parties may explore the possibility of settlement through Mediation. The transferee court would obtain the desire and wishes of the parties and proceed accordingly in this regard.

7. The parties are at liberty initially

to appear through virtual mode. If such request is made, the concerned court may favourably consider the same and thereafter, if need be, the parties can be asked to appear through physical mode.

8. The Transfer Petition is allowed accordingly.

9. Pending application(s), if any, shall stand disposed of.
