CIVIL APPEAL NO. 9514-9535

This appeal arises by Special Leave Petition filed against the Judgement and order dated 19.05.2010 of the High Court of Judicature at Allahabad, U.P. in First Appeal Nos. 592 of 1998, 599 of 1998, 602 of 1998, 604 of 1998, 596 of 1998, 597 of 1998, 1056 of 1999, 595 of 1998, 593 of 1998, 670 of 1998, 594 of 1998, 504 of 1998, 598 of 1998, 360 of 1999. 603 of 1998, 324 of 1996, 591 of 1998, 605 of 1998, 246 of 2003, 844 of 1999, 889 of 1999, 51 of 2005.

There are five respondents in Civil Appeal No. 9532/2010 and two respondents in all other appeals. Respondent Nos. 3, 4 and 5 are proforma respondents in Civil Appeal No. 9532/2010 and Respondent Nos. 1 & 2 are common and contesting respondents in all the appeals.

Notice of Lodgement of Petition of Appeal has been served on all the respondents. Respondent Nos. 1-2 in these appeals and 3-5 in Civil Appeal No. 9532/2010 have entered appearance before this Court through Mr. Ravindra Kumar and Ms. Neeru Vaid, Advocate respectively.

CIVIL APPEAL No. 721-22/2011

These are appeals by Special Leave Petitions filed against the judgment and order dated 14.01.2011 of the High Court of Judicature at Allahabad, in First Appeal No. 719/1995 and 324/1996 respectively.

These are an appeals by Special Leave Petitions filed against the judgment and order dated 19.05.2010 of the High Court of Judicature at Allahabad, in First Appeal Nos. 638/2002 and 599/1998 respectively.

Common Respondent Nos. 1, 2(i) & (ii) in both the civil appeals have entered appearance before this court through Ms. Neeru Vaid, Advocate.

However respondent no. 3 in both the civil appeals have not entered appearance before this Court though served with notice.

### **CIVIL APPEAL No. 1515-16/2011**

These are an appeals by Special Leave Petitions filed against the judgment and order dated 19.05.2010 of the High Court of Judicature at Allahabad, in First Appeal Nos. 557/1995 and 246/2003 respectively.

Lrs of deceased Respondent No. 1 in both the civil appeals have entered appearance before this court through Ms. Neeru Vaid, Advocate.

However respondent no. 2 in both the civil appeals have not entered appearance before this Court though served with notice.

### **CIVIL APPEAL No. 1517-18/2011**

These are an appeals by Special Leave Petitions filed against the judgment and order dated 19.05.2010 of the High Court of Judicature at Allahabad, in First Appeal Nos. 552/1995 and 504/1998 respectively.

Common Respondent Nos. 1 to 3 have entered appearance before this court through Ms. Neeru Vaid, Advocate.

However respondent no. 4 in both the civil appeals have not entered appearance before this Court though served with notice.

### **CIVIL APPEAL No. 1519-20/2011**

Common Respondent Nos. 1 to 6 have entered appearance before this court through Ms. Neeru Vaid, Advocate.

However respondent no. 7 in both the civil appeals have not entered appearance before this Court though served with notice.

### **CIVIL APPEAL No. 1521-22/2011**

These are an appeals by Special Leave Petitions filed against the judgment and order dated 19.05.2010 of the High Court of Judicature at Allahabad, in First Appeal Nos. 1043/1995 and 603/1998 respectively.

**CIVIL APPEAL No. 1529-30/2011**

These are an appeals by Special Leave Petitions filed against the judgment and order dated 19.05.2010 of the High Court of Judicature at Allahabad, in First Appeal Nos. 167/1997 and 594/1998 respectively.

Common Respondent Nos. 1 to 5 have entered appearance before this court through Ms. Neeru Vaid, Advocate.

However respondent no. 6 in both the civil appeals have not entered appearance before this Court though served with notice.

**CIVIL APPEAL NO. 1593-94 OF 2011**

These are appeals by Special Leave Petitions filed against the judgment and order dated 19.05.2010 of the High Court of Judicature at Allahabad, in First Appeal Nos. 55 of 1977 and 1056/1999.

There are 9 Respondents in this Appeal. Respondent Nos. 1 to 8 are Contesting Respondents and Respondent No. 9 is Proforma Respondents in both the Civil Appeals.

There are 2 Respondents in these Appeal. Respondent No. 1 is Contesting Respondent and Respondent No. 2 is Proforma Respondents in both these Civil Appeals.

Respondent No. 1 has entered appearance through Ms. Neeru Vaid, Advocate in both the Civil Appeals.

However, Respondent No. 2 has not entered appearance before the Court though served with notice.

**CIVIL APPEAL NO. 1597-98 OF 2011**

There are appeals by Special Leave Petitions filed against the judgment and order

dated 19.05.2010 of the High Court of Judicature at Allahabad, in First Appeal No. 634/202 and 593/1998.

There are 2 Respondents in Civil Appeal No. 1597/2011 and 3 Respondents in Civil Appeal No. 1598/2011.

LR's of deceased Respondent No. 1 has entered appearance through Ms. Neeru Vaid, Advocate in both the civil appeals.

However, Respondent No. 2 in both the Civil Appeals and Respondent No. 3 in Civil Appeal No. 1598/2011 though served with notice.

### **CIVIL APPEAL No. 1575-76/2011**

These are an appeals by Special Leave Petitions filed against the judgment and order dated 19.05.2010 of the High Court of Judicature at Allahabad, in First Appeal Nos. 56/1997 and 597/1998 respectively.

Respondent Nos. 1 to 8 in both the civil appeals have entered appearance before this court through Ms. Neeru Vaid, Advocate.

However common respondent no. 9 in both the Civil Appeals have not entered appearance before this Court though served with notice.

### **CIVIL APPEAL No. 1945-46/2011**

These are an appeals by Special Leave Petitions filed against the judgment and order dated 19.05.2010 of the High Court of Judicature at Allahabad, in First Appeal Nos. 1047/1995 and 360/1999 respectively.

Common LR's of deceased Respondent No. 1(1 to 4) in both the civil appeals have entered appearance before this court through Ms. Neeru Vaid, Advocate.

However Respondent N. 2 in both the Civil Appeals has not entered appearance though served with notice.

### **CIVIL APPEAL No. 2946/2011**

These are an appeals by Special Leave Petitions filed against the judgment and order dated 19.05.2010 of the High Court of Judicature at Allahabad, in First Appeal No. 598/1998 respectively.

There are 9 Respondents in this Appeal. Respondent Nos. 1 to 8 are Contesting Respondents and Respondent No. 9 is proforma Respondent.

Lrs of deceased Respondent No. 1 (1 to 5) and 2 to 8 have not entered

### **CIVIL APPEAL No. 3096-97/2011**

There are 9 Respondents in this Appeal. Respondent Nos. 1 to 8 are Contesting Respondents and Respondent No. 9 is proforma Respondents.

Common Respondent Nos. 1 to 8 in Civil Appeal Nos. 3096-97/2011 have entered appearance before this court through Ms. Neeru Vaid, Advocate. Certificate of service in respect of Respondent No. 9 has been received but no on entered appearance so far.

### **CIVIL APPEAL NO. 4469-70/2013**
