O R D E R

1. Learned counsel for the petitioner submits that these Transfer Petitions are filed by the petitioner-husband seeking transfer of following cases:

- i. G.W.O.P. No. 1779/2022, from Principal Family Court, Hyderabad to Family Court, Borivali, Mumbai.
  - ii. Divorce Petition being F.C.O.P. No 2083/2022, from the Principal Family Court, Hyderabad to the Family Court, Borivali, Mumbai.
  - iii. Maintenance Petition being M.C. No. 440/2024, from Principal Family Court, City Civil Court, Hyderabad to the Family Court, Borivali, Mumbai.
2. Learned counsel for the petitioner submits that the wife had filed the above referred cases in the Court at Hyderabad because at that time she was living in Hyderabad.
3. It is further contended that since October 2025, the respondent-wife has started living with the petitioner-husband in his House.
4. Learned counsel for the petitioner-husband submitted that since the respondent-wife has started living with the petitioner-husband in her matrimonial House in Mumbai, the above referred cases may be transferred to the Family Court Borivali, Mumbai.
5. Issue notice, returnable on 25.05.2026
6. In the meantime, there shall be a stay of further proceedings in the following cases:
- i. G.W.O.P. No. 1779/2022, titled "Smt. Priya Jajoo Vs. Sri Kuldeep Jajoo" pending before the Principal Family Court, Hyderabad.
  - ii. Divorce Petition being F.C.O.P. No 2083/2022, pending before the Principal Family Court, Hyderabad.

iii. Maintenance Petition being M.C. No. 440/2024, pending before the Principal Family Court, City Civil Court, Hyderabad.
