O R D E R

1. The petitioner(s) challenge the judgment and order dated 11-03-2026 in CRMA No.1200/2026 and 1207/2026 titled "*Ramesh Madanlal Agrawal vs. State of Gujarat*" passed by the High Court of Gujarat at Ahmedabad.
2. Issue notice, returnable on 08.05.2026.
3. Ms. Swati Ghildiyal, learned Advocate-on-Record accepts notice on behalf of the State of Gujarat. Hence, the formal service of notice on the respondent-State is waived.
4. Learned counsel for the petitioner to serve a copy of the present petition to the learned counsel for the respondent-State within a period of one week.
5. Let counter affidavit be filed within two weeks. Rejoinder thereto, if any, be filed within one week thereafter.
6. In the event of arrest in connection with F.I.R. No. 11201001250001/2025 dated 02.01.2025 registered with CID Crime Gandhinagar Zone, the petitioners shall be released on bail by the Investigating/Arresting Officer on such terms and conditions as imposed and found to be just, fair and reasonable.
7. The petitioners shall make themselves available before the Investigating Officer on 13.04.2026 at 10:00 a.m. and on all such dates as they may be required.

8. Needless to add, the petitioners would maintain good conduct and not attempt to influence any of the witnesses, in any manner, till the completion of the trial.

9. The petitioners shall surrender their passports before the Trial Court.
