Das vs. State of West Bengal reported in 2005 (4) SCC 303.

SLP.NO.3477/2007:

Heard learned counsel for the petitioner and Mr. K.
Parasaran learned senior counsel. It is stated that the matter
has been fixed for 30.7.2007. It is stated that the respondents are
willing to appear on the 4th July. 2007 so that their application
can be disposed of in accordance with law. In view of this
statement, we are not inclined to interfere with the impugned
order which is an interim order. We make it clear that while
dealing with the application for bail the principles laid down by
this Court in Adri Dharan Das vs. State of West Bengal reported
in 2005 (4) SCC 303 shall be kept in view.

Since the other matters are listed on 4th July, 2007, we
are not inclined to interfere with the impugned orders which are
interim in nature. While dealing with these petitions the Court
shall keep in view the law laid down in 2005 (4) SCC 303. The
special leave petitions are dismissed accordingly.
