Heard Mr. Samyak Jain, learned counsel for the petitioner. None for the respondent.

IA No.83561/2018 and IA No.15623/2018 have been preferred for bringing on record the legal heirs of deceased respondent Nos. 1 and 2 in SLP (Civil) No.20177/2012 along with application for condonation of delay and setting aside abatement.
