O R D E R

In SLP(C) No.1108/12 Ld.counsel for the petitioner is granted two weeks time as a last chance for remitting the process fee and spare copy. If steps are taken, issue notice. If steps are not taken within the above time, place the matter before the Hon'ble Judge in Chambers for non-prosecution.

In SLP(C) No.24977/11 respondent No.1 is granted four weeks time as a last chance for filing counter affidavit.

In SLP(C) No.21601/11 Ld.counsel for the petitioner is granted four weeks time as a last chance for taking fresh steps against respondent No.1.

If steps are not taken against respondent No.1 within the above time, the matter may be listed before the Hon'ble Judge in chambers regarding non-prosecution.

In all other matters fresh steps have been taken. Service is awaited. The served respondents are granted four weeks time for filing counter affidavit.

In SLP(C) No.25098/09 respondent No.2 has appeared. Ld.counsel for respondent No.2 submits that a copy of the pleadings have not been served on him. Ld.counsel for the petitioner is directed to serve copy of the pleadings within two weeks and file proof. Respondent No.2 shall file counter affidavit within four weeks thereafter. Await return of notice of the remaining unserved respondents.

In all the above cases except SLP(C) No.1108/12 Ld.counsel for the petitioner seeks dasti against the unserved respondents. Granted. Spare copy is exempted.

In SLP(C) No.12171/09 service is complete. No further steps. Hence, place the matter before the Hon'ble Court as per rules.
