3. We find that the main judgment of the High Court dated 23.08.2022 passed in RFA No.2352/2017 already stands set aside by this Court vide judgment dated 21.10.2024, passed in C.A. No.11758/2024 @ SLP(C)No.7963/2023 and connected matters [Horrmal (Deceased) through his LRs. and others vs. State of Haryana and others).
4. Consequently, the appellants are also held entitled to the same amount of compensation as has been awarded to the other land owners

vide the above-cited judgment, except that the appellants shall not be entitled to any interest for the period of delay in filing these appeals. Ordered accordingly.

5. The appeals stand allowed to the extent indicated above.
