UPON hearing the counsel the Court made the following
O R D E R

1. Dr. Aditya Sondhi, learned senior counsel appearing on behalf of the respondent no. 3, - Christ (Deemed to be University) as an extraordinary measure, has taken instructions and submits that as an exceptional case, the petitioner will be permitted to take 8th semester examination in the month of May, 2026. He has also gracefully stated that the petitioner will be permitted to take 7th semester examination after completion of 8th semester in due course. As this is an extraordinary concession offered by the University with the intervention of Dr. Sondhi, it is necessary for the petitioner to pass the examination with 50% marks.
2. Learned counsel for the petitioner submits that his client will also clear three back-log exams.
3. We make it clear that the order passed by us, is in the peculiar facts and circumstances of the case and the same shall not be treated as a precedent.
4. With these observations, the Special Leave Petition is disposed of.
5. Pending application(s), if any, shall stand disposed of.
