O R D E R

M.A. Nos.1088-1089/2026 and M.A. Nos.1090-1091/2026

1. These applications are at the instance of the Vadodara

Mumbai Expressway PKG-08 Private Limited (original respondent) in SLP (C) Nos.622-623/2026 and SLP (C) Nos. 1567-1568/2026, respectively, seeking modification of the order passed by this Court dated 09.02.2026 to the extent that the applicant be permitted to furnish bank guarantee of any scheduled bank rather than any nationalised bank as directed by this Court.

2. We heard Dr. Abhishek Manu Singhvi, the learned senior counsel appearing for the applicant and Mr. Ankur Mittal, the learned counsel appearing for the NHAI.

3. The NHAI has no serious objection as such if the applicant furnishes an unconditional and irrevocable bank guarantee of any scheduled bank subject to satisfaction of the same by the Registrar General of the Delhi High Court.

4. In view of the aforesaid, we modify para 24 read with para 10 of our order dated 09.02.2026 as under:-

"We permit the applicant to furnish an irrevocable and unconditional bank guarantee drawn on a scheduled bank to the satisfaction of the Registrar General of the Delhi High Court."

5. With the aforesaid, the Miscellaneous Applications stand disposed of.
