O R D E R

1. This appeal is directed against the judgment and order passed by the High Court of Judicature of Andhra Pradesh W.P.M.P. No.8391 of 2006 in W.P. No.6565 of 2006, dated 20.04.2006, wherein the High Court has refused to grant any interim prayer as sought for by the appellants.

2. Heard learned counsel for the parties to the *lis*.

3. It is an admitted fact that the Writ Petition is still pending before the High Court.

4. Since the appeal is against refusal to grant an interim prayer, we decline to entertain this Civil Appeal.

5. However, we would request the High Court to dispose of the Writ Petition pending before it as expeditiously as possible, at any rate within a year's time from the date of receipt of the copy of this Court's order.

6. All the contentions of both the parties are left open.

7. The Civil Appeal is disposed of accordingly.
