O R D E R

The petitioners have not been granted affiliation for different courses recognized by the National Council for Teacher Education by the Board of Secondary Education.

Hence, the relief claimed in these petitions is with regard to the affiliation for the academic session 2012-2013.

Learned counsel appearing for the Board of Secondary Education, on instructions, which we sought has submitted before us that the academic session 2012-2013 is already over and the examinations are scheduled for July, 2013 and that without affiliation, no admission can be granted to any student under the norms and regulations of the National Council for Teacher Education Act. Affiliation is required by the petitioners to grant admission but no relief can be granted in these cases as the academic session 2012-2013 is over. The Special Leave Petitions and writ petitions are dismissed. In case the petitioners approach this Court or any other Court for relief with regard to the academic session 2013-2014, the Court will pass appropriate
