O R D E R

The ld. Advocate, Mr Shrikant Deshmukh appearing on

behalf of Mr M.Y.Deshmukh, Advocate-on-record only is present for some of the petitioners in some of the SLPs. No

other Advocates are present for any of the litigant. In most of the SLPs, some of the respondents are yet unserved.

In some cases, petitioner has failed to pay process fee/spare copies in time. In some cases, notices are returned unserved.

On 26.8.2011, my predecessor has granted 10 days' time to file process fee and spare copies, therefore, now there is no sense in granting further time to the petitioner to confirm service on unserved respondents in such cases. However, in the interest of justice all petitioners in all SLPs are permitted to file process fee and spare copies, as last chance before 16.11.2011. If it is done, issue fresh dasti on unserved respondents in all SLPs. If not paid, list all matters before the Hon'ble Judge in Chambers for non-prosecution.
