We have heard learned counsel for the parties.

The respondents filed Writ Petition before the Punjab and

Haryana High Court seeking a direction to the concerned Nagar

Panchayat and the State of Punjab to regularise their services.

The writ petition was allowed by the order under challenge and a

direction was issued to consider their claim for regularization in

accordance with prevalent policy. It was further directed that in

case their claim for regularisation is accepted, necessary consequential relief may also be granted. An identical matter has been considered by this Court in State of Punjab & Ors. v. Lakhwinder Singh & Ors., 2006 (13) SCALE 434.

For the reasons given therein, the appeal is allowed and the judgment and order under challenge is set aside. The matter is remanded back to the High Court for a fresh decision of the Writ Petition. It is made clear that this Court has not expressed any opinion on the merits of the claim made by the concerned employees. No order as to costs.
