O R D E R

1. Petitioner challenges the judgment and order dated 05.03.2026 in R/Special Criminal Application (Quashing) No.3142/2026 passed by the High Court of Gujarat at Ahmedabad, titled "*Padamsingh Dhulsingh Sisodiya vs. State of Gujarat & Anr.*".
