O R D E R

When the hearing was resumed, Mr. R.S. Suri, learned senior counsel appearing for the appellants in Civil Appeal Nos. 1482-1498 of 2012, titled Vodafone Mobile Services Limited versus State of U.P. and Others, pressed the Interlocutory Application Nos. 18-34 of 2015 and submitted that the State of U.P., by issuing Notification, granted exemption in respect of transfer of immovable properties by persons including non technical - Information Technology, Bio Technology, Business Process Outsourcing Units, Call Centers, Agriculture Equipment Units etc.

If that be so, then the interlocutory applications
needs to be considered first, before proceeding with further
hearing of the appeals.

Learned counsel appearing for the Respondent-State
