O R D E R

1. Leave granted.
2. We have heard the learned Senior Counsel appearing for the appellants and the learned ASG appearing for the respondent.
3. The appellants have been arraigned as an accused and seek regular bail in connection with FIR No.86/2024, registered at Police Station E.O.W., Mandir Marg, New Delhi for the offences punishable under Sections 420, 406, 467, 468,

471 and 120B of the Indian Penal Code, 1860.

4. Admittedly, the chargesheet has been filed, and therefore, the continued incarceration of the appellants is not required. We also take note of the period of incarceration undergone by the appellants.
5. In such view of the matter, we are inclined to set aside the impugned order passed by the High Court and grant bail to the appellants.
6. Accordingly, the impugned order stands set aside, and the appellants are granted bail, subject to the terms and conditions that may be imposed by the concerned Trial Court.
7. The appeals stand allowed, accordingly.
