UPON hearing the counsel the Court made the following
O R D E R

1. We find from paragraph nos. 34 and 35 of the impugned judgment

that a Special Committee comprising Senior Functionaries of the State Government was constituted and its recommendations, including 35.7.VI, have been approved by the High Court vide the impugned judgment.

2. The apprehension of the petitioners that, in the absence of an express demarcation of the wall, which is already dismantled, they are not sure where the 12.20-meter-wide road will be constructed. This aspect, in our opinion, can be effectively taken care of by the Chief Executive Officer of the Slum Rehabilitation Authority. If the petitioners have any grievance with respect to the demarcation at the spot, they may also approach the Chief Executive Officer of the Slum Rehabilitation Authority.

3. With liberty aforementioned, the special leave petition is disposed of.

4. All pending applications, if any, also stand disposed of.
