O R D E R

In these batch of cases, the petitioners are aggrieved by orders passed by the Kalyani University rejecting the request for affiliation to the Teacher Education of the petitioners' institutions for the academic session 2013-2014 saying that the cut off date fixed for granting affiliation by this Court in the judgment dated 13th October, 2012 in Maa Vaishno Devi Mahila Mahavidyalaya v. State of U.P. & Ors., was over for the academic session 2013-2014.

In IA No. 8 filed in WP(C) No. 276 of 2012, we have extended the time for submission of applications for affiliation to the Affiliating Body after the expiration of 15 days from the date of order passed by this Court and has further directed that the affiliating body will process the application and pass orders thereof within one month from the date of receipt of such applications for the academic session 2013-2014.

In view of our said order dated 28th June, 2013 passed by this Court in IA No.8 in WP(C) NO 276 of 2012, we quash the impugned order passed by the Kalyani University and direct that the Kalyani University will consider afresh the application of the petitioners for affiliation within a period of one month from the date of receipt of certified copy of this order and communicate its decision to the petitioners.

The Writ Petitions are allowed in the above terms.
