O R D E R

1. The petitioner challenges the judgment and order dated 18.03.2026 in CRP No. 897/2026 titled "*T.R.Arun vs.K. Jenny*" passed by the High Court of Judicature at Madras.
2. We are not inclined to entertain the petition on merits.
3. However, issue notice for exploring the possibility of settlement.

4. Mr. P. Harish Kumar, learned Advocate-on-Record accepts notice on behalf of the respondent. Hence, service of formal notice is waived.

5. Heard learned counsel on both sides. The submissions would reveal the desire of the parties to explore the possibility of a mediated settlement.

6. In such circumstances, the parties are directed to appear before the Coordinator, Mediation Centre attached to the High Court of judicature at Madras on 29th April, 2026 at 11.00 a.m. The Coordinator shall appoint a Mediator to enable the parties to make an effort to settle the matter amicably.

7. Initially, the parties are permitted to appear virtually and thereafter, they shall appear as per the directions of the Mediator.

8. Pending conciliation, the impugned judgment and order dated 18.03.2026 in CRP No. 897/2026 shall remain stayed.

9. List the matter along with Mediation Report on 15.07.2026.
