Leave granted.

These appeals are directed against common judgment dated 25.4.2011 of the learned Single Judge of the Rajasthan High Court whereby he dismissed Civil Miscellaneous Appeal Nos.76/2006, 80/2006 and 84/2006 filed by the appellant against the award passed by the Motor Accident Claims Tribunal.

Learned counsel for the appellant submitted that Civil Appeal No. 1654 of 2012 arising out of SLP (C) No.28691/2011 filed against the impugned judgment was allowed by this Court vide order dated 03.02.2012 and the matter was remitted to the High Court for fresh disposal of the appeal. This has not been controverted by learned counsel for the respondents.

In view of the above, these appeals are allowed in similar terms. The detailed reasons and the directions contained in order dated 3.2.2012 passed in Civil Appeal No.1654/2012 titled Pradeep Kumar Sharma v. Kalicharan and another shall be read as a part of this order.
