O R D E R

1. These 4 (four) appeals are directed against the common impugned interim order dated 09th March, 2026 of the National Company Law Appellate Tribunal, Chennai¹ in Company Appeal (AT) No.131 of 2025 and connected appeals.

2. We find from the impugned order that the NCLAT had fixed 01st April, 2026 for hearing the appeals. However, we are informed that on 1st April, 2026, a Special Bench was in session and a prayer for filing reply having been made, the NCLAT has deferred hearing till 08th June, 2026.

3. We are not inclined to entertain these appeals since the appeals before the NCLAT are pending.

4. However, since the NCLAT evinced its desire to hear the appeals and had fixed 1st April, 2026 for hearing thereof, which could not fructify for reasons beyond its control, we are of the considered opinion that interest of justice would be sufficiently served if the appeals are disposed of with a request to the relevant bench of the NCLAT to advance the date of hearing of the appeals to Monday, i.e., 27th April, 2026, subject to its convenience, and to decide the same in accordance with law as early as possible thereafter. Ordered accordingly.

5. In the event the relevant bench of the NCLAT is disabled to commence hearing on and from Monday next due to some unavoidable reason, we leave it open to such bench to fix any other date in the same week or the following week to facilitate compliance of this order.

6. No precipitative action be taken by both sides until further orders are passed by the NCLAT.

7. All points on merits are kept open.

8. Pending application(s), if any, shall stand disposed of.
