O R D E R

Issue notice.

Mr. Shivaji M. Jadhav, advocate, appears and accepts notice on behalf of respondent No. 1 in Special Leave Petition (Civil) No. 18500 of 2012 and respondent No. 1 in Special Leave Petition (Civil) No. 20332 of 2012 [arising out of First Appeal No. 1343 of 2004]. Service on these respondents is thus complete.

Notice shall be issued now to unrepresented respondents only.

The following interim order shall remain operative until further order :-

(i) The petitioners shall deposit the enhanced amount of compensation as per the impugned judgment with the Reference Court, i.e., the District Judge, Nasik within two months from today.

(ii) Upon deposit of the above amount, the expropriated owners/claimants shall be entitled to withdraw 50% of the enhanced amount by the High Court unconditionally.

(iii) As regards remaining 50% of the enhanced amount, the expropriated owners/claimants shall be entitled to withdraw the same on furnishing solvent surety/security to the satisfaction of the District Judge, Nasik within three months of the intimation of such deposit.

(iv) In case, the expropriated owners/claimants do not furnish solvent surety/security for withdrawal of the 50% of the enhanced amount within the time above noted, the District Judge, Nasik shall invest the said amount in a nationalised Bank initially for a period of one year, renewable thereafter for the same period every time.
